



**Dual Language Kindergarten  
Schedule & Fees  
July 19, 2021 - June 24, 2022**

Welcome to EastLake Church Children's Center. Our center is a Christian preschool/child day care center, Transitional Kindergarten and Kindergarten operated by the EastLake Church, a nonprofit corporation. We serve children 2 – 6. The school is licensed by the California State Department of Social Services Community Care Licensing Division.

**ANNUAL REGISTRATION FEE:** nonrefundable - **\$150.00** per child or **\$225.00** per family  
Active Military Registration - **\$100.00** per child or **\$175.00** per family

**CURRICULUM FEE:** **\$100.00** Due at time of registration

**ANNUAL TUITION:** Monthly electronic transfer of tuition installments on the fifth of each month: Payments are July 5th thru June 5th (½ pmt). *For students enrolled August or later, and/or students that are withdrawn and re-enroll during the school year, there will be a full month June installment.* A one month written advance notice is required for withdrawal or for a reduction in your child's schedule. Tuition will continue to be due at the current tuition rate through the one month notification period.

**Kindergarten Class:** **\$945**  
8:30 am to 3:00 pm Mon. – Thurs.  
8:30 am to 1:00 Fridays

**Class with before & after school care** **\$1065**  
6:30 am to 5:30 pm - Mon-Fri

**One Time Before & After Care** 24 hour advance request is required: *approval is dependent upon space availability.*

**Early Drop Off:** (7:00-8:30)  
**\$15.00**

**Extended Care Reserved:** (6:30-5:30)  
**\$30 (M-Th)/ \$50 (Fri)**

**ADDITIONAL FEES:**

**Late Pick Up Fee** – Any unreserved or unscheduled time. **\$15.00** for each 10 min. interval or portion thereof  
**Returned Payment Fee** - Account becomes delinquent. **\$30.00**  
**Late Payment fee** - As of the 6<sup>th</sup> of the month. **\$30.00**

Delinquent account balance is due and payable by cash, cashiers check , debit or credit card. Any account over 30 days delinquent may cause dismissal of the student from our center as well as the account being sent to collections. Interest and past due balance will be charged at the current legal rate.

**There are no reductions in tuition for holidays, illness, school breaks, family vacation or suspensions.**  
**As noted above there is a ONE MONTH written advance notice required for Kindergarten withdrawal or for a reduction in your child's schedule.** Tuition will continue to be due at the current tuition rate through the notification period. EXCEPTION: No withdrawal notice with an effective date of June 1st or later will be accepted regardless of the date of notification; thereafter all accounts will pay through their contract period.

A 30 day notice will be given to parents and posted at the school anytime there is a change in fees.
